 THIS AGREEMENT made and entered into this _____ day of _____, 2017 by

 and between _____, a member (hereinafter called the "MEMBER"), of the SHAWNEE MISSION RADIO CONTROL CLUB, INC., a Kansas not-for-profit corporation, hereinafter called the "RC"), and the Johnson County Park and Recreation District, a quasi municipal corporation, (hereinafter called the "DISTRICT"). The Johnson County Park and Recreation District owns and operates Shawnee Mission Park in Johnson County, Kansas, and has therein a facility commonly known as the RC Flying Field, hereinafter called the "FIELD", which is used for flying radio-controlled miniature airplanes and related recreational activities and the RC and the DISTRICT have heretofore entered into that certain agreement dated May 20, 2004 whereby RC may conduct radio controlled flying activities for its members at the FIELD, the MEMBER agrees as follows:

1. Waiver. The MEMBER agrees and acknowledges that the DISTRICT shall not be responsible for damages to property or injuries to persons which may arise from or be incident to the exercises or privileges granted to the RC or its members, or for the damages of the property or injuries to others who may be at or on the FIELD at their invitation, arising from or incident to any governmental activities at or on the FIELD or related facilities.
2. Indemnity. The MEMBER agrees to indemnify, defend, and hold harmless the DISTRICT from and against claims, demands judgments, loss, expense, or liability on account of or arising from any accident, injury, or damage to person or property on or about the FIELD where such accident, injury, or damage results from any act, omission, or negligence on the part of the MEMBER or his/her invitees or guests, including payment of reasonable attorney's fees and litigation expenses incurred by DISTRICT.
3. Insurance. The MEMBER states that he/she is a current member in good standing of RC. They agree to follow the Academy of Model Aeronautics (AMA) safety guidelines while conducting any model airplane flying activities at the FIELD. They further agree to maintain such RC membership at all times while conducting any model airplane flying activities at the FIELD in order to be covered by the insurance protection provided by AMA, which is required by the DISTRICT.
